The Foundation board submits the amount available for distribution to the League board after the August Foundation board meeting. The League board then votes on how much of the allowable distribution to accept. The distribution is restricted to the League's Community Program, and the League reports its specific use of these funds to the Foundation board along with the request for funds.
