To fund the clinic, members formed a Luncheon Club - the genesis of today's Tea Room. The Tea Room supports the League's exempt purposes by serving as a training facility where members are educated in the discipline of service, which is then carried into various community service projects the League undertakes. The training and education afforded by the Tea Room enable members to be more effective and efficient community volunteers. The Tea Room exclusively serves its Tea Room patron members, League members, and their guests.

Form 990, Part III, Line 4b, Program Service Accomplishments:
 Community Program and Community Support Services: Community projects are a main focus of The Junior League of Houston, Inc. During the 2024-2025 fiscal year, the League served individuals through community projects addressing a broad spectrum of needs in Houston and surrounding areas. Many of these programs are initiated by the League and fully supported through League volunteers and funding. League volunteers serve many people - infants, children, women in crisis, families, and the elderly; in many places - hospitals, museums, camps, and schools; and in many capacities - docents, mentors, and program facilitators. During the 2024-2025 fiscal year, the League combined volunteer time with direct financial support through grants, collaborative efforts, and community projects.

Officers shall assume their duties at the general meeting in May and shall serve for one year. The membership also votes to approve the Board of Directors proposed by the Executive Committee.
