## 2023 – 2024 Junior League of Houston Foundation

In 1999, the Junior League of Houston created the Community Endowment. In 2005, a separate organization, the Junior League of Houston Foundation, was created and Community Endowment assets were transferred to the new Foundation. In 2022, the Building Preservation Fund assets and Building reserve assets were transferred to the Foundation to be invested and managed by the Foundation. The Foundation’s board is charged with overseeing the management, investment and distribution of funds. The purpose of the Community Endowment Fund is to sustain and expand the League-designated Community Program in perpetuity, as well as help fund new initiatives. The purpose of the Building Preservation Fund is to assist with capital purchases including technology-related capital purchases when deemed appropriate and to maintain and preserve the Junior League of Houston building for the long term.

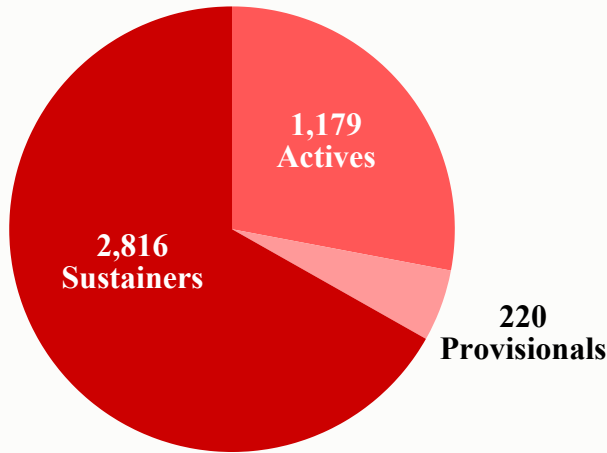

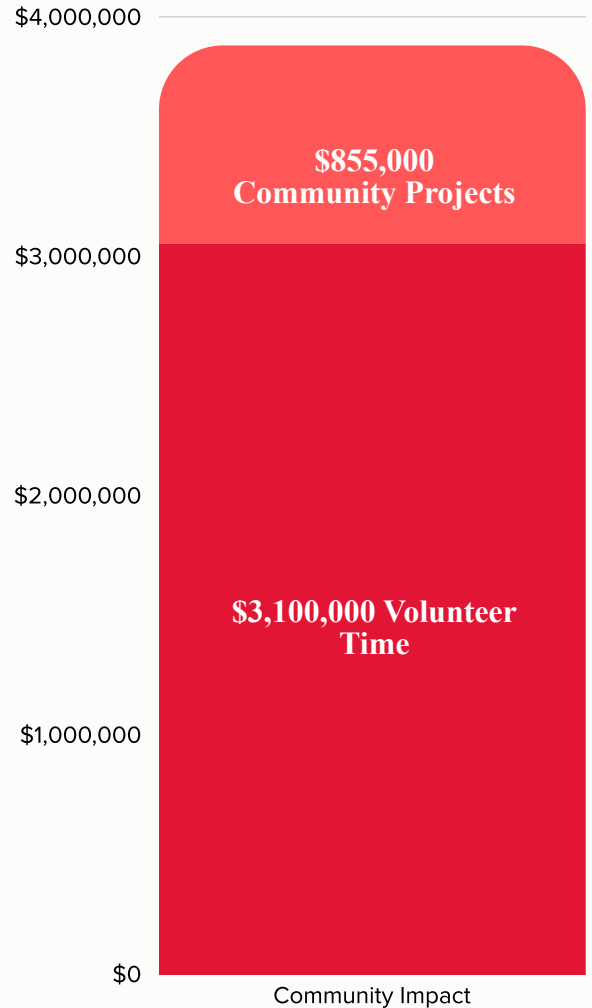
